Biographical History

Gretchen Staples Swinnerton (7 October 1892-9 April 1983) was born in Lathrop, Missouri, the second child of William Crawford Staples and Maude Lois Parshall.

Gretchen was married three times. Her first marriage was to William Emery Harvey – they were married on 26 October 1909 and they were later divorced on 19 April 1913. She was then married to Earl S. Richardson. For a time in the mid-1920s, Gretchen worked as a journalist for a Kansas City newspaper. She then moved to San Francisco to work for a newspaper there. Her last marriage was to artist James "Jimmy" Guilford Swinnerton, whom she most likely met in San Francisco, and they were married on 18 January 1936 in Las Vegas, Nevada.

The images in this collection were taken by the Swinnertons during their annual trips to Northern Arizona, which was one of Mr. Swinnerton's favorite areas to paint.

The collection consists of photographic material documenting the Swinnertons' annual trips to the Native American reservations of Northern Arizona.
