This collection is composed of some lecture bureau announcements about Philip Johnston; a clipping about his father, W. R. Johnston, 90 years old; an important collection of photographs of W. R. Johnston's missions at Moenkopi, 1896 - and Tolchaco, 1900 - 1918; and a copy of the Coconino County Court record of the trial of Hosteen Boagetin (Begwo-ettin) for murder, 1900, a crime of which he was acquitted.

2. Wolden Philip Johnston was born Sept. 14, 1892, in Topeka, Kansas. He came to Arizona with his parents, Margaret W. and William Riley Johnston, missionaries to the Navajo, in 1896. He was the interpreter for President Theodore Roosevelt at the age of nine, when his father took several Navajos to Washington to discuss land problems of the Leupp area. This resulted in the Leupp Extension of the Navajo Reservation. The Johnston's first mission was at Moenkopi, but in a few years they established one at Tolchaco, on the Little Colorado River. Philip graduated from Northern Arizona Normal School in 1915. In 1917 he enlisted as an infantryman in the U.S. Army. Ca. 1920 he entered the University of Southern California, from which he received a BS in Civil Engineering. He worked for the Bureau of Engineering of the City of Los Angeles until his retirement in 1950. In the 1920's (?) he married Bernice During Werld War II, Philip devised a code in the Eastman. Navajo language for the Marine Corps, and for two years was engaged in recruiting and training young Navajos for this service. He spent his vacations in Flagstaff and the Navajo Reservation, maintaining his friendship with the playmates of his childhood at Tolchaco. He published many articles on Arizona and California places, lectured with his own fine slides on the Navajos, "The Code Talkers", etc. He was a frequent visitor at the Museum of Northern Arizona. His death occurred on Sept. 11, 1978.
