Introduction:

William C. Miller was born on April 22, 1910 in Tacoma, Washington. In 1929, Miller found himself accompanying a group of fellow astronomy students from the California Institute of Technology into the mountains of Arizona to test the effectiveness of various telescopes. As a result of that summer, he was again recruited in 1930 for a similar project, but the Depression caused him to withdraw from CIT the following year. Nevertheless, he maintained the many contacts made through those endeavors, and became increasingly interested in the many archaeological sites they had encountered while on their astronomical missions. By the 1930's, Miller was working as a photographer and optical engineer, eventually receiving a B.A. from UCLA in 1947. All the while he continued to become more interested in archaeology and essentially taught himself the basic skills of the discipline. In 1949 Miller began working in the photographic laboratories of Mount Wilson Observatory, where he remained employed until his retirement in 1975. But it was his other passion of archaeology in addition to his astronomical and photographic training that led to his becoming involved with MNA.

By 1953, Miller was already a veteran of numerous trips to the regions of the Navajo and Glen Canyon systems when he set out for White Mesa. But with that trip, he began what would end up a life-long association with MNA, and working with MNA archaeologists during these survey expeditions while on his summer vacations from Mount Wilson Observatory. While he was well known in among astronomers for his pioneering work in the use of color photography in the field, he also garnered much attention from archaeologists for his publications regarding two pictographs in Arizona which he hypothesized depicted a supernova which had occurred in 1054. Perhaps his most significant contribution to the advancement of this region's archaeology, however, was his photographic skills and tireless efforts to survey many of the areas of this region previously unknown to archaeologists. His work with the likes of Robert Euler, Dave Breternitz, Alexander Lindsay, Christy Turner and many others has thus resulted in the collection here. These materials were graciously donated to MNA upon his death in 1981. Certainly, his prodigious assemblage of photographs are the most valuable aspect of the collection, but they will appear listed under a separate aid. This finding aid, however, does detail all of the papers, drafts, maps, correspondence and assorted ephemera he produced and collected in the course of his 40 + years of work in northern Arizona and southern Utah.

As for the organization of the collection, it is fairly self-explanatory and the table of contents should provide the minimal direction needed to evaluate the materials. Miller's numerous notes, drafts and reports are listed chronologically, as is his correspondence. It is hoped that this aid will provide the researcher with a simple and effective means to delineate which documents they wish to view.
